Who is a Child? In the vast realm of Indian legislation, the definition of a child is a multifaceted concept, each facet carefully carved to serve a unique purpose. According to the Juvenile Justice Act of 2015, a child is someone who has yet to embrace their 18th year, ushering in a separate realm of justice to protect their innocence. Meanwhile, the Right to Education Act, 2009, paints a vibrant canvas for children between the ages of 6 and 14, ensuring the brilliance of knowledge touches each one. The Child Labour Act of 1986 shields those below the tender age of 14 from perilous toil, nurturing their childhood. And the POCSO Act of 2012 stands guard over those below 18, shielding them from the shadows of sexual offenses. These diverse definitions weave a legal tapestry, safeguarding the unique rights and aspirations of India's children.

Comprehensive Child Protection Framework: In the intricate tapestry of child protection in India, several key facets play a vital role in safeguarding the well-being of its young citizens. First and foremost, prevention efforts take a proactive stance to avert harm and risks to children, with programs promoting positive parenting, family support, and awareness campaigns. A study featured in the Indian Journal of Psychological Medicine (2019) underscores the success of a positive parenting initiative, enhancing parent-child relationships and mitigating behavioral issues.

Secondly, the identification and reporting of children at risk stand as a critical aspect. Healthcare professionals, teachers, and helpline services are on the frontline, recognizing and reporting child protection concerns. Teachers, as highlighted in the Journal of Family Medicine and Primary Care (2019), play a pivotal role in this process.

A robust legal framework forms the third facet, providing the essential backbone for child protection. These laws address a spectrum of issues, including child abuse, labor, marriage, trafficking, and exploitation. A comprehensive analysis in the International Journal of Human Rights and Constitutional Studies (2018) scrutinizes the legal framework and laws in India.

Additionally, the fourth facet encompasses the role of Child Welfare Committees (CWCs) and Child Care Institutions (CCIs). These institutions respond to cases of children in need, with assessments and evaluations featured in the Indian Journal of Child Health (2017) and The International Journal of Indian Psychology (2019), respectively.

The fifth facet focuses on rehabilitation and support for children who have experienced abuse or exploitation, involving counseling, medical care, and education. Research published in the Indian Journal of Psychological Medicine (2017) assesses the positive impact of counseling on trauma-affected children in India.

Child-friendly justice systems form the sixth facet, ensuring child-sensitive legal procedures protect children involved in legal processes. The Indian Journal of Pediatrics (2016) emphasizes the importance of child-friendly courts in India.

Involving children as active participants constitutes the seventh facet. Programs encourage their engagement in decision-making processes, as highlighted in Children and Youth Services Review (2018), recognizing the significance of their voice in shaping policies and programs that affect their lives.

Lastly, the eighth facet recognizes the need for international cooperation in tackling cross-border issues such as child trafficking. Collaboration among South Asian countries is underscored in The Lancet Global Health (2018) as a means to prevent and respond effectively to child trafficking. Together, these facets weave a protective cocoon for the children of India, striving to ensure their rights, safety, and well-being.

Progress and Achievements in Child Protection: India has made substantial progress in establishing a robust legal framework for child protection, with key legislation such as the Juvenile Justice (Care and Protection of Children) Act, 2015 (JJ Act) and the Protection of Children from Sexual Offences (POCSO) Act, 2012. These laws provide the foundation for addressing issues related to child abuse, neglect, and exploitation. The JJ Act recognizes the unique needs of children between 16 and 18 years who have committed offenses, focusing on rehabilitation and reform rather than punishment. It identifies various vulnerable categories of children and ensures their care, protection, and rehabilitation through Child Welfare Committees (CWCs) and Child Care Institutions (CCIs). This legal framework streamlines adoption processes, promotes foster care, and emphasizes the rehabilitation and social integration of children in need of care and protection.

The POCSO Act contributes to child protection by establishing child-friendly special courts designed for swift justice while minimizing trauma for child victims. This legislation allows for the recording of the victim's statement through video conferencing and with the presence of a support person. It also prescribes stringent punishment for sexual offenses on children, acting as a deterrent. The Act empowers CWCs to oversee the rehabilitation and support of child victims during trials.

Another significant achievement is the establishment of Child Welfare Committees (CWCs) and Juvenile Justice Boards (JJBs) at the district level. These bodies make decisions in the best interests of children, ensuring their protection and rehabilitation. CWCs, composed of experts in child psychology, social work, and law, provide care and protection to children in need. JJBs handle cases involving children in conflict with the law.

India's national child helpline (1098) and state-level helplines play a crucial role in child protection, offering a platform for children to report abuse and seek assistance. Managed by trained counselors and social workers, these helplines operate 24/7 and serve as immediate sources of support for children in distress.

Furthermore, child adoption reforms under the Juvenile Justice (Care and Protection of Children) Act, 2015, have prioritized the best interests of the child. The reforms streamline adoption procedures, establish the Central Adoption Resource Authority (CARA) as the nodal agency, and ensure transparency and timeliness throughout the adoption process. This focus on domestic adoption and safeguarding the child's rights enhances the prospects of children finding permanent, nurturing homes through legal adoption.

II. Challenges To Child Protection In India

Child Labor

India confronts a deeply troubling predicament as it wrestles with the pervasive problem of child labor. Countless children find themselves ensnared in hazardous labor conditions, a stark deprivation of their fundamental rights to education and a secure childhood. The statistics, sourced from the Ministry of Labour and Employment, are disquieting: the 2011 Census reveals a staggering 43,53,247 children, aged 5-14, embroiled in child labor across the nation. The state of Karnataka, in particular, bears the weight of this crisis, with an alarming count of 2,49,432 child laborers. This unsettling reality underscores the urgent need for comprehensive action and change to safeguard the well-being and future of India's children. 

Child Trafficking

Child trafficking in India represents a grave violation of fundamental human rights, preying upon the vulnerabilities of individuals by offering deceptive promises of improved livelihoods, better living conditions, and support for their families. These assurances, though seemingly legitimate, render men, women, and children susceptible to exploitation, perpetuating a cycle of abuse and suffering. To combat this heinous crime, the Ministry of Home Affairs has taken resolute measures to fortify law enforcement responses. They have allocated substantial funding to state governments to establish Anti Human Trafficking Units (AHTUs) across all districts. These units play a pivotal role in investigating trafficking cases and curating a comprehensive database, shedding light on the extent of the issue and the individuals involved. Notably, an allocation of Rs. 100 crore from the Nirbhaya fund has been dedicated to establishing new AHTUs and reinforcing existing ones. The remarkable result is the operation of 768 AHTUs and 20 states and union territories achieving their objective of implementing AHTUs in all districts. A significant step in comprehending the extent of this crisis was initiated in 2016 when the National Crime Records Bureau (NCRB) began amassing data on human trafficking cases. This data is systematically published in a dedicated chapter titled "Human Trafficking." These distressing statistics bring to light the alarming reality that India faces, with 3,390 reported cases of child trafficking in 2019 alone. This includes 2,016 cases of forced labor, 912 cases of sexual exploitation, and 234 cases of other forms of exploitation.





Within this tapestry of tragedy, the age group most profoundly affected was 18-35 years, constituting 48% of total deaths. Piyush Tewari, the visionary leader of SaveLIFE Foundation, underscores the pressing need for the unwavering enforcement of road safety provisions and child safety measures mandated by the Motor Vehicle (Amendment) Act 2019. 

The lack of adequate foot over bridges, pedestrian crossings, and ignorance of road safety regulations are potential factors contributing to such accidents in the capital city.

In 2021, Delhi, India, witnessed 60 young individuals falling victim to fatal road accidents, with 48 of them being male. The total number of fatal road accident victims in the city reached approximately 1,239 during the same year. Notably, pedestrians accounted for the highest number of casualties, comprising over 40% of the total victims.




