

# Generalized Failure In Detention: An Al Qaeda Thing

(M. R. Pinheiro)/Twins Of God<sup>1</sup>

---

## **Abstract:**

*In this paper, we write about the state of detention services in three major countries, United States, Australia and Brazil. We prove that marginals are not being arrested or recorded in the system or punished in the ways prescribed by the people and instead people who are innocent (in a definite manner) of the crimes marginals have been accused of have been staying in jail and paying for their crimes, like the satanic claim Jesus did. To make it all worse, these innocent people are still enduring atrocities in detention because the actual cops and managers, with the formation, training and vocation the people decided was enough for those positions, are not there overseeing all: instead we have usurpers, so people who cut all that short and became a cop through either agreeing with the homicide of the actual cop or killing them themselves and usurping their IDs. Ways to heal society from the evil are then presented.*

## I. Introduction

The first prison in the USA was the Walnut Street Prison, in Pennsylvania, which started activity in 1773 as a jail ([1], p. 20), and became a penitentiary in 1790 ([1], p. 27).

The first prison in Australia was a jail (back then called 'gaol', Co-pilot says it was exactly the same thing as jail, just an older way of saying jail employed by the English) in New South Wales in 1797 [3]. The first penitentiary appeared in 1842 in New South Wales and was called house of correction or Parramatta Gaol [3].

The first penitentiary in Brazil was the 'Casa de Correcao' from Rio de Janeiro, which started hosting prisoners in 1834 ([2], p. 348, and Co-pilot) and at such a time it provided confinement and labor to those (Co-pilot), full services having started being provided only in 1850 ([2], p. 348), so educational programs, vocational training, healthcare services, religious services and recreational activities on top of confinement and labor (Co-pilot).

In this paper, we study three cases of arrest, court procedures and incarceration/termination, one for each one of these three main countries, all involving maximum security prisons: we prove that the person who pays the penalty is not the person who committed the crimes. We also prove negligence and incompetence of police, staff and managers that way and make a case on usurpation being the main cause for those. We then present solutions.

## Development

**Formal Perpetrator of the First Case:** Johnny Frank Garrett

**Actual Perpetrators:** Al Qaeda and Al Qaeda 'Nelson'

**Formal Victim:** Tadea Benz

**Actual Victim:** Unknown (usurper of the existence of Tadea Benz at the time of the crime) and unknown (usurper of the existence of Johnny Frank Garrett at the time of the crime)

**Year:** 1981

**Incarceration:** Maximum security, Texas (2 different prisons according to Co-pilot)

'Tadea Benz', 76 yo [6], whose profession was that of universal sister, so sister of all of us on Earth, as for the definition the Catholic Church has got for this social function (care, compassion, and support for all people, regardless of their background, according to Co-pilot), was attacked with top violence by a perpetrator who entered her room to kill and rape her at night in the St. Francis Convent in Amarillo, Texas, USA [4].

Al Qaeda 'Nelson' (Indian male figuring as 'Nelson Ricci Pinheiro', my legal brother in Brazil, where I figure as 'Marcia Ricci Pinheiro', result of Al Qaeda usurpation of a family, and he exists in multiples. He spent decades in Porto Alegre, Rio Grande do Sul, Brazil, playing such and I watched him kill by hand the original Nelson (circa 1974), who was, at the time, being healed by an army clinic located in an area full of green grass, with me unable to tell exactly where that was, even though it was definitely Brazil. Also his father,

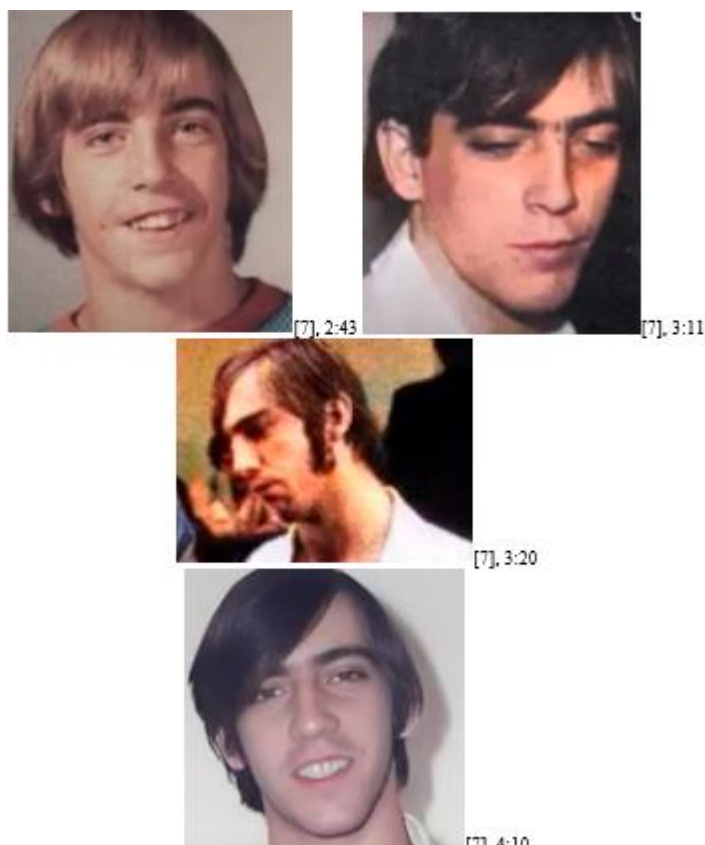
the original Jayme Braganca Pinheiro, got killed, also by hand, in such a place, so that my legal father, the devil, from Al Qaeda, could exist under his name) would have moved them all (so sister and perpetrator), which basically means that the perpetrator who would be blamed for all and the sister had Al Qaeda bugs in their heads (they get in without surgery, either through a hole drilled on the top back of the head or through the ear and they are usually inserted at night: Al Qaeda has people who specialize in entering other people's houses and bugging them. They apparently were always accompanied of a locksmith in 1972 and/or 3 when I had light contact with those procedures and they were doing Enmore and surrounding areas) and 'Nelson' used these bugs to force them to say, think or do things. 'Nelson' would have landed his Macquarie spaceship (the spaceship made through a slave who was an undergraduate student of engineering of Asian background and who had presented a project to the Macquarie University staff for a spaceship moved by gasoline and hardly detectable by radar, whose body I saw while he was still alive, so about 20yo) on the roof of such a convent, the flat top probably being the main reason for the attack to take place there, even though I have never seen a picture of such a roof, just guessing, and discharged the other perpetrator by putting him on ground. I believe this man was on phase out while travelling in the spaceship (phase out means cancelling awareness of the victim) and probably also while being discharged and put on the ground as well as when being picked at home. 'Nelson' would then have broken the window himself while wearing a glove and would then have entered through the entry where the clean knife was found (he said he would leave the knife there for me to know how he entered). The sister would be bugged in the head because the entire convent should be usurpers, just like the sisters in the Catholic college where I studied, Colegio da Companhia Santa Teresa de Jesus (I was there up to 1986 and since 1980), and one of the sisters who was more my friend, 'Maria Jose', would have even told me the reason as to why she would have accepted usurping the life of the original sister (facilities, accommodation, food and sports): that means they were all Al Qaeda slaves, so those from my college and this convent (every usurper is bugged in the head, we believe before they are approached, and brainwashed to accept the offer of Al Qaeda/the devil, and therefore they are all Al Qaeda slaves or devil's workers). The sister was then put into a state of deep sleep and incapable of emitting a sound before 'Nelson' ceased her through bug. She probably felt no pain as he raped her and he then stabbed her with gloves on and the "excoriation and abrasive injuries" [4] were because he himself rubbed something on the front and back of her neck to pretend it to be strangling. I believe that would have been a brush. He then hit her head with the crucifix so that it would have contusions [4]. The forensic pathologist would have said that the cause of the death is strangulation [4] and 'Nelson' started a conversation with me to tell me that that sort of mark would mean strangulation. I told him that I didn't think so. Yet, I now think he is the one who goes with it even when I say it isn't so, since Leinha seems to change all and follow me instead. To be correct, he then usurps the pathologist, in my humblest, like, for some reason, they always do things that way if they want to change the narrative from a place that is considered to be where people are more into analysis or scrutiny of things. Here what Co-pilot has to say about him: "Dr. Ralph Erdmann was the pathologist involved in the case of Sister Tadea Benz. He conducted the autopsy and determined that the cause of death was manual strangulation. Dr. Erdmann was not from the military; he was a civilian forensic pathologist. However, his career was later marred by controversy due to numerous allegations of misconduct and inaccuracies in his autopsy reports." That obviously means the marginal ruined the career and biography also of this one by using one more of its slaves (usurpers are all bugged in their heads, therefore are all slaves of Al Qaeda). They got to prove that he committed serious mistakes and he got given 10 years probation [5]. Even with all that, I do think there is probably some ritualistic meaning involved in all he did: injuries to the head (hit with an object), back and front of the neck (abrasion with an object) and stabbings to the chest. In my best guess, there is some satanic/Baal thing there. He then goes to the window, where 'Johnny' is in phase out, and presses the knife handle against his hand. While doing that, he thinks that maybe the fingerprints won't remain on the handle, so that he also marks the blade. It is only after doing that that he stabs her. Even though he told me he wanted the (basically) the pathologist to say it was strangling, he was doing a ritualistic thing instead, and he couldn't get 'Johnny' to put his hands around her neck, since he was in phase out and it would have been complicated to bring him in, like his body would be rigid and he had to go through the same path he entered. I believe the window was not big enough to allow him to pass someone without leaving some trace for forensics. He then puts the knife (obviously to be found with forensics) under the bed and goes back to the outside of the window, where 'Johnny' is there, as a statue, waiting for him. He then puts 'Johnny' back to the spaceship and takes him home. Leinha then organizes the fake witnesses, as she did in the case involving 'Suzanne Armstrong' ('Nelson' murdered 2 women, a man and a baby: the target was one of the women, 'Suzanne Armstrong', the one who got raped, but the other one went to save her and got killed and then a neighbour entered the house through the back hearing the yells and also got killed (all moved by 'Nelson' to do these things in this way, though), this one having been replaced by Al Qaeda together with the baby who they made stay in the house for more than 5 days without water or food [6]). This particular sister would have been chosen because she would be the oldest in the convent (Al Qaeda Leinha, who figured as Lea Ricci Pinheiro in Brazil, my legal sister, would have given me a chance of 'contributing' to this plot (she would never

tell me it was about perpetrating crimes or anything like that, she just consulted me by asking if she had a choice to advise a marginal on whether to rape and kill one in a particular group of nuns, who should he advise him to get, the youngest or the oldest and why. I obviously would have opposed the entire thing and would have asked her to stop the possibility, but she then would say it is just for curiosity then, what I thought would be better or less worse and that is when I would end up saying something. In this case, I said oldest because the youngest would not yet have lived her life). We then get to know that the entire convent was moved by 'Nelson', since none of the sisters ever got out to see or hear anything during all that. 'Nelson' would have made 'Johnny' go inside of the convent 2 days before that thinking, to his inside ('Johnny's'), that he was after money, when 'Nelson' then forced him to touch the sister's headboard (and 'Nelson' would then have made him think of all he said [4], so that he was after reaching the cross while he did that), which means the victim, when moved, can remember the things they have actually done while being moved and is believing they are thinking with their own heads during those moments. 'Johnny' does not remember having been in the convent the night the sister was murder because he was all the time in phase out, so that he must have been picked from his bed/sleeping and he must have been put back into it in the end.

In this case, we know the only person who deserves being blamed for those atrocities is 'Nelson', even though all should be recorded by police as involved to the side of perpetrator and notes should be made to explain why 'Johnny' is not guilty as well as to detail their own statements also to facilitate further studies on the Al Qaeda bug activity/use.

The only one figuring as perpetrator in the police records so far is 'Johnny', so the usurper figuring as 'Johnny Frank Garrett', since the original Johnny was probably at least on his 3<sup>rd</sup> usurpation at that stage. That means that not even the right name of the perpetrators (2: Al Qaeda and 'Nelson') for this crime we have so far in the police records. Actually, not even the right name of the victim, since she is also a usurper.

The male giving the statements we see on [4] was however the same male whose fingerprints were put on that knife that night and on the headboard of the sister 2 days before that.



The picture to the left would be that of the person who committed the crime and the picture to the right would be that of the person who was arrested, according to [7]. [7] also states that the age of the perpetrator was 17 yo, so that they are claiming that the picture to the left belongs to a 17 yo male. Please observe the so many differences between these two men: mouth (the one to the right has small mouth compared to the one to the left), hair (the one to the right has black hair and the one to the left has light brown hair) and nose (the one to the right has nostrils with finishing that are well marked while the one to the left has discreet finishing on those).

That means that the man who was arrested was certainly not the man who they selected as perpetrator, even though they share the same usurped ID, so that both figure as Johnny Frank Garrett even though Johnny must have been a very compliant and lovely Christian kid who had his existence usurped for the first time probably before the age of 5 yo.

The picture in the middle (3<sup>rd</sup> one) is advertised on [7] as the looks of ‘Johnny’ at the court and here we see yet another man occupying/usurping his ID therefore (nose and design of the chin, for instance, make you immediately notice the contrast). We then know that the man who got prosecuted is definitely not the man who got arrested and the perpetrator is yet another man.

The last meal of the man is something Al Qaeda Leinha would have discussed with me at least once, so that I am sure that, if not the case with all of them (yet I do believe it is), the last man occupying this ID in prison was entirely moved by Al Qaeda even there (so that Al Qaeda would have made him think that was his wish for last meal and here we notice how grotesque they want to portray the white Christian native men, since that is what he more than likely was even though Al Qaeda hides that from us (Wikipedia, for instance, does not bring that information in the entry involving his name [8], detail probably omitted because someone made a movie out of this case [9] and therefore they feared people who matter to them would find out what kind of rhetoric they are giving to others who are not them) , that he wanted strawberry with chocolate ice cream, like all simple like that and not really matching. The image of the man who would have ordered the last meal , according to [7], would have been the last picture you see above (so 4<sup>th</sup> in presentation order), which is that of yet another man: the nose is very different from all the others, since it is fuller to the sides by the end of it, in terms of flesh, than the other three noses, just to mention one of the most remarkable differences.

We are then sure that the man who perpetrated is not the man who got arrested and that is not the man who went to court and that is not the man who got executed, and those are 4 very different men, even though they all share the ID of Johnny Frank Garrett. I believe all the men who played Johnny in prison had no awareness of the usurpation and genuinely thought they were such (brainwashing via Al Qaeda head bug). I also think all of them got killed before each new usurpation.

**Formal Perpetrator of the Second Case: Mert Ney**

**Actual Perpetrators:** Al Qaeda, Al Qaeda ‘Nelson’

**Formal Victims:** Michaela Dunn and Lin Bo

**Actual Victim:** Unknown (usurpers of the existence of Michaela Dunn and Lin Bo at the time of the crime) and Unknown (usurper of the existence of Mert Ney at the time of the crime)

**Incarceration:** Maximum security, New South Wales (Goulburn Supermax, acc. to Co-pilot)



'Mert', who appeared with blood on his top before the press on the day of his arrest, had been raped by 'Nelson', 'Nelson' then dressed his clothes because his own got dirty from drinking her blood as he pierced her neck to do that during the time of the spill (according to the own 'Nelson'), so while it was freshest and still with life in it. It is apparently a satanic ritual, mentioned in the satanic bible [13]. According to the ritual, 'Nelson' would have to get rid of his own clothes and shoes after he performs the rite, so after he stabs her like that and drinks her fresh blood. He would have to rape the male before doing her and dress him in her clothes. 'Nelson' was also supposed to put her blood on the raped male's top as he finishes, like perhaps each time he stabs her neck and drinks her blood he makes another mark on the male's top. The male presenting the facts about satanism, 'Nico', lets us know that they 'make sense' to him [13]. In this case, The couple represents a Christian couple in love. As 'Nelson' conversed with me: 'would a person who is in love with another open the door for the other if they knocked?' I said, 'it depends'. He said, 'wouldn't that be true, that all people in love would open the door to the person they are in love with?' I said, 'not necessarily: if they had a gun pointing at them and they could see through the magic eye or if they looked as if they had hate and could have come to attack them, then they wouldn't'. He then said, 'a person in love with another would open the door to the other', like he never accepts counter-argumentation, regardless of how sound it is, which we learned is proper of satan: if things do not conform with his reasoning, the 'makes them be'. In this case, the satanic were then thinking that would be a Christian (white) couple in love. 'Nelson' is then going to fix the narrative to what it should be, according to the satanic: men should have sex with men and men who remain as men, not women. A man should keep his wife virgin (the wife of Baal would be a virgin and that is the demoniac deity Al Qaeda adores) and usurp the life energy of her love and lust. 'Nelson' dresses the Christian man with the wife's clothes to imply that that is what the Christian man became with what he actually did/felt: he became a woman/her (therefore a rejected creature, the brotherhood is only for men). Now he made her get killed with what he did, which was reaching peak of love, like he made his 'brother' do that to her and now he carries the proof on him that that has been done, what should have been done by himself (which is why he bothers staining the top with her blood to the same number of stabbings and drinks), perhaps because he would have reached the maximum height of 'falling in love', when only killing the wife can make the man only usurp her life/heaven's energy and, in not being able to do that with her alive, for feeling so much love, he does that with her after she is killed. 'Nelson' dresses the clothes of the Christian man to say he is now him, the Christian man, since the man didn't really do it, so that he was replaced with his 'fixed' version, which is now him, that is, 'Nelson'. The Christian man then has to appear in the most public way as possible as guilty for those crimes so that satanism is advertised as being the way things naturally go in human kind (so to pass the idea that men are naturally like that, that the satanic scriptures are the most logical ones therefore, the ones that show largest understanding of men) to those who are not yet part of the brotherhood and so that the satanic learn (once more) that that is what will be done to them each time they fail doing 'their stuff' like that. Notice here once more that logical is only Our God: satan, the 'son' of the devil (created by him), just like Christ is the son of God, wants us to believe that any heterosexual couple is a loving couple, like there is no chance they are simply friends or even simply people who don't attack each other being from opposite genders. He also wants us to think that 'peak of love' or love can be reached from simply seeing each other, like these two never even conversed in life.

Nobody would think of testing ‘Mert’ for rape, since he was ‘seen’ stabbing someone. ‘Nelson’ would have put both the female victim, ‘Michaela’, and ‘Mert’ in phase out. He would have written a text message instead of recording his voice saying things even though he is told to have held his mobile camera to show the murder to someone else via movie [14] because it was ‘Nelson’ who did that, since ‘Mert’ was on phase out (here ‘Nelson’ would also have followed the satanic bible’s instructions and he was then satanizing the male: making him sin somehow). ‘Nelson’ would then have put ‘Mert’s’ left hand in the blood of ‘Michaela’ [14] because he calculated that he was right handed, like most people, and therefore the right hand would be holding the mobile, like just to make it look more credible.

It is very likely that this particular usurper never said any of those words in his life (‘fuc...’, ‘bro’ or ‘the fear’). I believe he was replaced before he ‘admitted’ to the murder and stabbing [14], just because he would have no recollection about that and Al Qaeda then needed to prepare a new usurper who had that memory plus ‘Nelson’ seems to always kill the men he rapes.

Leinha would have organized the fake witnesses for ‘Nelson’, just like she did with the case involving ‘Suzanne’ [6]. ‘Lin Bo’ would have been moved by Al Qaeda so that she wouldn’t see the aggressor and ‘Nelson’ would also have been really quick. Upon seeing the man running with knife in his hands, she infers it was that man who stabbed her.

Please observe that the 3 men in the pictures appearing before the one in which ‘Mert’ is seen with his entire body (in this paper) are extremely different: noses and ears (as for the one to the right and on its own below that one), for your naked eyes, should make you see the contrast involved.

In this case, the man they arrested is not the man who went to the courts and not only more than one different man went to the courts but the man who stayed in jail is probably another one too, like we have seen happening in plenty of cases. We now believe all these men get killed, as said before: killed and replaced. We also now believe officers are put on phase out when they are swapped. If that happens in a court, then they all are put in mandrake/phase out during the swap.

**Formal Perpetrator of the Third Case:** Marcelo Fernando Pinheiro Veiga

**Actual Perpetrators:** Unknown, moniker Marcelo Piloto (Usurper of the ID of Marcelo Fernando Pinheiro Veiga who calls himself Marcelo Piloto)

**Formal Victim:** Several (21 arrest warrants, 55 police incidents) Most remarkable one is probably ‘Lidia Meza Burgos’, since he killed her while incarcerated inside of his cell, 16-53 stabbings, got her under the title prostitute and used a dessert knife to kill her (he would have done that to remain in Paraguay, since otherwise he would have to live inside of the Brazilian prisons instead. ([15], [16] and [17]). This must be yet one more Al Qaeda slave (probably a Christian woman brainwashed to visit him in jail)

**Year:** Several (figures of warrants and incidents given here are for those happening before or in 2015)

**Incarceration:** Maximum security, Rondonia (Penitenciária Federal de Porto Velho, acc. to Co-pilot)

We here got interested in first talking about ‘Lidia Meza Burgos’. Please observe two pictures of this woman that appeared in the press:



Notice how different these pictures are. Brazil is a very judgemental Country, so that here Al Qaeda Leinha excelled at making the victim actually look like a prostitute (the picture of [19] actually shows part of her body inside of a mini-dress of those glued to the body and she even wears eyeliner in the style of Leinha). Yet, it seems that only one woman died in that prison cell and that was the one appearing on [16], a picture that came from the civil police file from Paraguay, where the prison cell of the homicide was located. I would say the woman from [16] definitely does not look like a prostitute (it is the expression of the eyes and mouth but also the treated hair and fine clothes (the picture is trimmed). Al Qaeda is then doing her satanization as they force her to figure as prostitute and is also doing more of their defamation campaign. I think I am sure she was bugged and then moved by Al Qaeda to appear there, at that jail cell, which means she never had a chance not even of knowing/being aware of what was happening when she died in such a brutal way. The ID used was probably usurped when the legitimate owner was still very young, so that this would be its nth usurpation. It is probably a tactic ID, so used just for the purpose of anonymizing the victim to best. The woman occupying this ID before the victim, who would have been put to carry it just for that day and those hours, would have died without anyone acknowledging her death (so that her body would have, for instance, being incinerated in a double cremation or incinerated with her alive in it in a sacrifice to Baal or eaten by Al Qaedas/natural cannibals and so on). The other three women, as we explain better later on in this paper, would also have died.

The woman from the ‘Mert Ney’s’ crime, ‘Michaela Dunn’, goes through exactly the same process. See here:

[21] would be the picture of the woman usurping this ID at the time of its death in the police files from NSW. [22], leftmost one is probably the picture Al Qaeda Leinha imagined would make the ID look more like a prostitute, as for what she tells ‘Nelson’ that she is doing. Notwithstanding, she conversed with me before ‘working’ on that and, as always, I opposed that she even let that happen, but, as always, she would have told me that that had to happen and what is it that she could then do to ‘work’ a little for us, basically. I then asked her not to make her look like a prostitute. She then decided for putting less effort into the task, so that she gave her these huge earrings, as she consulted me as for whether people could believe that that was an identifying element for prostitutes in society. I said not necessarily but she decided that was the best she could do, so that she went with it. The pictures above correspond to 4 different women and most different features are perhaps nose and skin color if you are using your naked eyes. There are probably more pictures connected to this ID in the media.

Again 'Michaela Dunn' would have died long time ago, probably before five years old, like the first time the ID was usurped would probably be at such age.

Al Qaeda is then doing her satanization as they force her to figure as prostitute and is also doing more of their defamation campaign. She was bugged and so was her flatmate (Co-pilot says she shared the apartment with another woman), so that 'Nelson' would have made her answer the door and let him in and he also would have made her flatmate go out to a particular place where 'Nelson' would 'take care of her' after finishing with 'Michaela'. I imagine this woman lived on the top floor in Clarence Street (Co-pilot doesn't know that much and I could not find such piece of information online either), since 'Nelson' would then be able to park his Macquarie spaceship on the roof and get to her house, so that she might have been chosen already because of that. I believe this boy was an undergraduate from some university, probably one whose work or idea 'Nelson' stole, just like the spaceship from the Macquarie University. Before 'Nelson' approaches him, he would have bugged him somehow, so that he would not be rejected and would still be obeyed. He probably collaborated with 'Nelson' on some project, like it was with the one from the Macquarie and 'Nelson' probably waited until the project was completed, like it was with the one from the Macquarie, when he then invited him to a spaceship trip, which he accepted because not many people would refuse that but also because he had been programmed to be his slave. After he enters it, he probably gave him phase out. He then probably turned him on by the end of the trip and had him appearing in the magic eye when 'Michaela' looked at the door to see who was visiting her. She then opened the door to him but 'Nelson' then entered with him and put both in and turned them off/gave them phase out and then positioned their bodies in the way he wanted and then did it all. She was then never advertised as a prostitute and Al Qaeda organized this also in terms of narrative of the media, so that her flatmate was also usurped and, when the usurper came back, she started giving the Al Qaeda narrative for the both of them, which included saying that they were 'running a sex service through the Clarence apartment' (Co-pilot).

With 'Lidia Meza Burgos', 'Nelson' would have gone to Paraguay to 'help' Marcelo Piloto, since 'Nelson' said he did not want to go back to Brazil. 'Nelson' then went with his Macquarie spaceship and parked at the back, since it seems that this prison has 2 levels. 'Nelson' carried 'Lidia' in the spaceship to the prison with her completely unaware and in phase out. She was bugged, so that it was relatively easy to get her to meet him somewhere close to her home. After they left the bar or pub or wherever they met, which I see as an empty place in my head as he described things to me, like nobody else apart from them, still daylight, and they were sat at a table for two people at the front of this place, where there were several tables and chairs at the front and to the right side of those entering the place, they seemed to have had nothing to drink or eat, they walked out. 'Nelson' invited her to do something, probably go to see his spaceship, but she refused, and that was by the end/front of the own place, to the left of those entering, so that he then turned her off and carried her to the spaceship, which was parked by the end of this small 'corridor' formed between the end of the roof of the place where they were conversing and the start of the other roof, of the next building/house or whatever that was. He then put her inside of the vehicle and went to the prison, parking at the back. The manager of the prison greeted them as they arrived at the main entry of the building where the cells are, since 'Nelson' had organized things with him, and 'Nelson' gave phase out to everyone else in that prison, just like he did with the Suffolk base when perpetrating a particular part of the attack. He didn't want to carry her in his arms because otherwise the manager could notice she was not a prostitute, so that he made her walk with him by putting her on 'mute' and state of mostly unaware, as Al Qaeda did to me a few times in bed (you don't understand what is happening, since your eyelid is kept shut, you have doubts as to where things are happening in reality or not, so that, if there is someone moving you, as he was doing, you tend to move with them believing you might be being taken by someone to a hospital or somewhere where they will take care of you), and he embraced her to his side, probably left, as they entered the building. He then gave the narrative to the manager and asked him to show where the cells were, posteriorly passing an order for him (the manager) to stay behind, at the main gate of the prisoners' cells after instructing him on how to get to the target's cell and giving him the key for the targeted person's cell. He then directed himself to the cell, opened it, the target was like everyone else there apart from the manager in off and he then placed the secondary target inside of the cell. He looks around the cell and cannot find anything that could be used to kill her but he had come prepared: he thought that, in a prison, specially maximum security, even though they wouldn't give knives to prisoners, most people would accept that they could give dessert knives to them, so that he had one of those in his pocket. He then killed the secondary target, probably wearing gloves, and probably after making sure the target's fingerprints were on the little knife before he stabbed her. He then left the cell, closed it, directed himself to where the manager was, told him the narrative, for him to put in the books like that, left and turned everyone on when he was already in the spaceship. The woman was left with a bit of life, since she was still taken to the hospital [23]: that was because otherwise the expression of her face could be seen as unnatural, I assume.

The ID of Lidia Meza Burgos was probably usurped when the legitimate owner was still very young, so that this would be its nth usurpation. It is probably a tactic ID, so used just for the purpose of anonymizing



the victim to best. The woman occupying this ID before the victim, who would have been put to carry it just for that day and those hours, would have died without anyone acknowledging her death (so that her body would have, for instance, being incinerated in a double cremation or incinerated with her alive in it in a sacrifice to Baal or eaten by Al Qaedas/natural cannibals and so on). Leinha was kind enough to converse with me about these things and ended up helping us to best that she could in that situation, so that, for instance, she would have made it possible that we acknowledged the passing of all the other women in the pictures she spread in the media. Those women would not have occupied the ID as if it were a tactic ID because otherwise Lidia would have formally died more than once and that is not what Al Qaeda does. There are certainly more women appearing in the media as bearers of this ID (so beyond those that we somehow mention here) and to all those these remarks apply.

Al Qaeda Leinha told me about 'Napoleon' and the brotherhood [13]: she decided for not joining it and I advised her to not even go there. 'Nelson' would then have told her about it only between 1972 and 1999. She told me about 'Napoleon' and seemed to be checking on whether I believed it or not and I said I didn't believe that, like, if he had much intelligence/wisdom then he couldn't have taken part into such a thing. Now I know I was obviously implying that he had been usurped and it was the usurper who joined such a thing, obviously then to run the defamation campaign of the satanic/Al Qaeda of the time over the ID's legitimate owner's existence. We notice that the tag given in [13] is brotherhood, therefore a group made of men. 'Nelson' conversed with me about the possibility of adding transgenders to their brotherhood, so about the how he could do such a thing, yet he reached the conclusion that such is not possible (and we see that from the satanic practice we here described, that involving 'Mert Ney').

Now let's examine the images of the men who played Marcelo Piloto:



Nose, skin color (one is whitest of all, one is reddish plus white, one is tanned plus reddish and one is white but not as white as the whitest one) and shape of the face should make you see, even with a naked eye, that all the pictures above are different, so that each one of them presents a different man. It is probably possible to find even more different imagistic versions of this ID. We then see that the guy who was in prison in Paraguay is not the same guy who is transported to Brazil and none of those is the guy who was initially recorded by the police of Brazil as being Marcelo Piloto.

Co-pilot says that Marcelo Piloto was executed by the Paraguayan authorities in 2018 but [24] says he was still alive in 2024 and was going to be judged in Brazil, where he was, for several crimes, but the only homicide they mention is that of 'Lidia'. Even though Al Qaeda 'Nelson' said he was going to help Piloto to get

what he wanted, which was not going to Brazil anymore, the homicide of 'Lidia' made him be sent to Brazil immediately instead (one day after the assassination) [15]. According to Al Qaeda Leinha, prison time, when anyone in multiples gets arrested, is shared among the multiples in an even way, so that Piloto would have to be in multiples in this case, since he is communicating with 'Nelson' and therefore is aware of having been put in jail by him/Al Qaeda. In this case, all Pilotos should be marginals, just that they would have committed different levels and number of offences each (the basic cluster should contain 5 multiples with one 'black behind' (one person that shares ID but remains 'silent' or always outside of the media in terms of association of their image with that particular ID): that is because human life is taken to last for 100 years and each takes 20. It is hard to tell the difference between a case like this and a case of simple homicide of several by Al Qaeda with them playing with the ID, but notice that if they get swapped during the same court procedures then it cannot be the case of the 'guilty' multiples: they would have to be innocent and simply appear as the ID holders in a very temporary manner (so even less than half an hour), just like 'Lidia' and 'Michaela'. Besides, she told me the basic multiples were 5 but we sometimes see more images than 5, so that we would imagine that, when that happens, at least a few innocent people paid the price for the marginals. I also don't think that, in a case with death penalty, even accepting that the marginals would think time in prison should be shared, this even when the penalty is life in prison, Al Qaeda would let one of the multiples be killed, so that we are sure the one who gets killed is innocent.

The name of the legitimate bearer of the legal identity used by Marcelo Piloto has a 'Pinheiro' in it. Pinheiro means pine and is therefore a tree. Al Qaeda Veronica let me know that that meant New Christian (having the name of a tree in the surname). Co-pilot then told me: "there is a historical context where people migrating to Brazil acquired new names that often included elements of nature, such as trees. This practice was particularly common among the "New Christians" (Cristãos Novos), who were Jewish converts to Christianity during the Portuguese Inquisition. Many of these individuals migrated to Brazil and adopted new names to assimilate and avoid persecution." Al Qaeda usurped 'with me' a family called Ricci Pinheiro and therefore they are always confirming they follow satanism: they chased those who were universally regarded as God's people in an attempt to exterminate all good in human kind, all chances the God of Abraham, Isaac and Jacob, who is the only authority the devil recognizes as such, since He created him as an angel, puts him back to being an angel somehow, since the devil wishes for becoming Our God originally, so Lord of us all and this world.

[25] brings details on how Al Qaeda run prisons are like: a prisoner is allowed to go to shower on his own, first of all, so not with others and supervised by officers; other prisoners, who are not having a shower, are allowed to enter the shower cubicle without being officially seen, which basically means they are on the lose inside of the complex, not confined, yet they are the most violent ones, the ones imposing rules, which frontally oppose society's rules, to the prisoners who there live; a prisoner is left in a shower that does not have a camera in it; and finally not only the prisoner is subjected to this sort of violence each time but this violence remains as extra-official and uncared by the Al Qaeda government, which should obviously immediately have acted in the most 'violent' way as possible (strength of action that is proportional to that applied by the perpetrator) instead, and those who should be defending the prisoner's rights (human rights people, their lawyer, counsellors, psychologists, psychiatrists, medical practitioners and so on) are obviously Al Qaeda people as well, since instead of prosecuting the manager of the complex for personal liability, the government for negligence and the perpetrators for the perpetration, they placidly watch and listen. Al Qaeda Leinha told me about this case: she wanted to punish him because, if he was from their bunch, he had to accept always being in crime instead of playing the rhetoric of society, which is that of repair (for damages and injuries), recovery (of soul, mind and body) and restoration (adequately return the individual to society, so, for instance, making sure he worked during the prison time and therefore is not now used to being idle or lazy or unproductive and perhaps thinking he enjoys that situation).

Al Qaeda Leinha actually told me that Al Qaeda gets a list of the cases police is currently investigating (my best guess is hacking from usurping the existence of the person who elaborated their computer system for that sort of thing) and, through that list, they identify serial killers and go after those following the clues the police has got in order to get to them before they do and put a dummy there, who is going to then be the person who is arrested and blamed in their place (I believe the computer program collects and stores milestones of the case and, from entering their system through the usurper/Al Qaeda slave, they get to know all the steps of compliance). A famous example would be that of the backpackers' killer, when 'Ivan Milat' got arrested [27] in place of the actual killer and it was Leinha who personally took care of this one. I believe I met and even lived with the actual killer of the backpackers. I believe his current ID is Andrew Clarkson, who lived in North Melbourne, Victoria, when I met and dated plus shared house with him. I had to ask a close friend to help me leave the place immediately (she found me accommodation where she stayed, with her boyfriend, and he came to pick me up on the same day I called and right before 'Andrew' arrived the day after he brought the saw home) after I sensed that he was going to kill me: he arrived home with a saw, which I immediately thought was to dismember me, and he said that was to trim the trees when I entered maximum alert mode and asked about it.

## II. Conclusion

Al Qaeda is a satanic group and all satanic people seem to follow what is inside of the satanic bible, which we believe was created at most by time of the Canaanites, before the Old Testament starts being written. We believe they come applying these satanic teachings since at most back then, which basically means they subtract possibilities of the non-satanic to acquire knowledge/information/wisdom and keep all that to themselves. During the time when the Old Testament started being written, only the satanic would have been able to read and write, so that they were able to forge all written in the bible from start. They did the same with the 'sacred' (no book can be sacred: books are just books, all written by humans, nothing supernatural in those who wrote) books, so at least the books of Islam and Judaism as well. That basically means that the words in those books, as expected (God does not write anything Himself and He cannot make sense if giving written things to us, specially to only a few of us or worse one of us), never belonged to Our God and are actually the devil imposing his tokens to us, even though sometimes, and very frugally, his words may reveal some truth of Our God (so say when Jesus said, 'come to me children', or when the Qoran says that the man can only have more than one wife if he can give equal love to all of them (that is only possible if the wife is one, so that that is a wise way of asserting that, like it would always be possible to have wife1 at the hospital and wife2 at home: for the man to be able to give equal love, he would have to be physically present in both existences in the same way, but he is only one and therefore can only be either at the hospital or at home and therefore, even with 'only' two, it is not possible to give them equal love).

We here studied 3 famous criminological cases where the perpetrator is told to be in maximum security prison: one American, one Australian and one Brazilian case. In all three cases, we concluded that the person compliance formally recognizes as perpetrator is not the same person who remains in prison and the person who dies, if there is death penalty involved, is innocent (99% of chance). We also concluded that some swaps are made from within the clusters of multiples [26], so that those in jail do share the same legal ID, therefore figure as legitimate bearers of the name of the accused and therefore are guilty of crimes somehow, even though unrelated ones to the accusations officially recorded by authorities as the reasons for their imprisonment. We also concluded that a special Al Qaeda, Leinha, used the allowance to spread pictures of the main female victims of 2 of the cases we studied here to make it possible that we acknowledge the passing of other 3+ women who once held the ID appearing as legitimate ID of the formal victim.

The consequences of having Al Qaeda/satanic authorities, managers and support people are nefarious: no adequate incarceration, no possible recovery, serious crime being perpetrated against the incarcerated inside of the prison, routines outside of common sense for prisoners and staff, installations that are logically unacceptable and so on.

There is a satanic brotherhood that exists in our world since a time that is similar to that marking the writing of the satanic bible. The usurper of Napoleon's brother was apparently a member of such a thing and his degree of pertinence was pretty high (33, coinciding with the age of Christ when he died) [13], which means he had done all or almost all literally in the book/satanic bible. It seems that even though lots of things Al Qaeda does are found inside of this satanic bible, yet another book, a Baal's bible, is found somewhere, a book describing other practices, such as usurpation, since I got told, by the marginal, that this satanic bible does not contain usurpation, even though it contains multiples. We also understand that it would be impossible for women to join such a thing, so the brotherhood, but 'Nicole Kidman', despite being a transgender, like Leinha (99% chance) and 'Lea Maria', would have actual women in her cluster of multiples (I have met at least one in person). Either the satanic bible has a different definition/rhetoric for the clusters of multiples or the brotherhood does but, whatever is not in the satanic bible should be in the Baal's bible in terms of Al Qaeda mainstream practices.

The solution is in, first of all, having the entire society turning to the only God that actually exists and seeks contact with us either directly or through Jesus since ancient times, the God of Abraham, Isaac and Jacob, since He keeps us away from the devil and anything connected to the devil, so also to his creatures (Baal, satan, Ashera, Moloch, etc.), and the things connected to the devil will always serve the purpose of stopping our spiritual evolution or regressing it and therefore will keep us further away from heavens.

Second, we must worry about photographing marginals (or those appearing as such) at waste: at the time of the arrest, at the time of interviewing them in the police premises, at the time of the courts and frequently while they are in detention, so at least once a month. Third we must worry about comparing pictures via computer each time in order to make sure we have the right person in detention and, if not, fix things in an adequate manner.

Third, we must replace the current managers of detention centres in all three countries studied with Christian/compliant people who have adequate training and experience, guaranteeing those are not usurpers (therefore demanding that they provide, as condition for hiring, pictures of at least 4 stages of their lives (baby, teen, 30yo and current) and those pictures pass rigorous usurpation tests (so say the computer cuts faces into halves and compares left side of one picture with right side of another, perhaps after some manipulations, so say

the face is sideways and the computer then has to ‘calculate’ the image of the face that is frontwards to only then compare).

‘Ivan Milat’ never killed the victims of the backpackers’ killer: that was an Al Qaeda job. The actual backpackers’ killer seems to be a male currently usurping [28] the ID of Andrew Clarkson and living in North Melbourne, Victoria, in 2001.

Al Qaeda seems to have a slave who usurped the existence of the mentor of the computer system used by the police in New South Wales and this system must have something like milestones collection (where detectives record results of their investigations on a daily basis), so that they get continuous access to the latest investigations regarding serial killers and they go after those before the police gets to them in order to replace them with a dummy, so that, instead of being arrested, they become an Al Qaeda slave.
