# Some Classes of Generalized Entire Sequences of Fuzzy Number

**Abstracta:** The object of the present paper is to introduce the sequence spaces  $\lambda_o$  (M,  $\phi$ , P) defined by the sequence of fuzzy numbers and  $p = (p_k)$  be any bounded sequence of positive real numbers. We study their different algebraic and topological properties. We also obtain some inclusion relations between these spaces. **Keywords and phrases:** Fuzzy number, entire sequence spaces, completeness, convergence , boundedness. ## I. Introduction

The concept of fuzzy set theory was introduced by zadeh [14] and subsequently several authors have discussed various aspects of the theory and applications of fuzzy sets such as fuzzy topological spaces, similarity relations and fuzzy orderings, fuzzy measures of fuzzy events, fuzzy mathematical programming. Matloka [7] introduced bounded and convergent sequences of fuzzy numbers and studied some of their properties. Later on sequences of fuzzy numbers have been discussed by Nanda [9] savas [12], Mursaleen [8], Thripathy[13] and Dutta [2] and many others. Ganapathy Iyer [1] studied the space of all entire functions. Maddox [5] generalised the space of all entire functions as a special class of sequences of complex numbers  $c_{o}(P)$ .

Let  $p = (p_k)$  be any sequences of strictly positive real numbers. The class of sequences defined by Maddox [6] was

When all the terms of  $(p_k)$  are constants and all equal to p > o we have  $c_o(p) = c_o$ , the space all null sequences. The special FK – space  $c_0(1/k)$  was studied by Ganapathy Iyer [1] who indentified it with the space of all entire functions.

Kampthan [3] studied the class,

 $\mathbf{X} = \left\{ f: f(z) = \sum a_n z^n, |n!a_n|^{\frac{1}{n}} \to o \text{ as } n \to \infty \right\} \text{ consisting of all entire functions of order 1}$ and type o and showed that X is a Frechet space with the total paranorm

Recently Nuray and Savas [ ] have defined the following space of sequences of fuzzy numbers

$$l(\mathbf{p}) = \left\{ x = (x_k) : \sum_k \left[ \overline{d} (x_k, \overline{o}) \right]^{p_k} < \infty \right\}$$

where  $(p_k)$  is a bounded sequence of strictly positive real numbers. Mursaleen and Metin Basarir [8] studied the spaces  $F_0(p)$ ,  $F_{\infty}(p)$  and F(p).

Our aim is to introduce the space  $\lambda_0(M,\phi, p)$ . We establish the condition for  $\lambda_0(M,\phi, P)$  to be identical with  $c_0(M,\phi, P)$ . Also we give the necessary and sufficient condition for  $\lambda_0(M,\phi, P)$  to be included in  $\mu_0(M,\phi, P)$ .

#### **II.** Definitions and Preliminaries

We begin with giving some required definitions and statements of theorems, propositions and lemmas. A fuzzy number is a fuzzy set on the real axis i.e. a mapping u:  $\mathbb{R} \to [0,1]$  which satisfies the following four conditions. (i) u is normal i.e. there exists an  $x_0 \in R$  such that  $u(x_0) = 1$ 

ii) u is fuzzy convex i.e. u  $[\lambda x + (1-\lambda)y] \ge \min \{u(x), u(y)\}$  for all  $x, y \in \mathbb{R}$  and for all  $\lambda \in [0,1]$ iii) u is upper semi continuous

iv) The set  $[u]_0 = \left\{ \overline{x \in R : u(x) > 0} \right\}$  is compact (Zadeh [14]) where  $\left\{ \overline{x \in R : u(x) > 0} \right\}$  denotes the closure of the set  $\{x \in R : u(t) > 0\}$  in the usual topology of R. We denote the set of all fuzzy numbers on R by E' and called it as the space of fuzzy numbers. The  $\lambda$ -level set  $[u]_{\lambda}$  of  $u \in E'$  is defined by  $\int \{t \in R : u(t) \ge \lambda\}, \quad (0 < \lambda \le 1)$ 

$$[u]_{\lambda} = \begin{cases} \{e \in R : u(t) > \lambda\}, & \lambda = 0 \end{cases}$$

The set  $[u]_{\lambda}$  is a closed bounded and non-empty interval for each  $\lambda \in [0,1]$  which is defined by  $[u]_{\lambda}=[u^{-}(\lambda),u^{+}(\lambda)]$ 

 $\mathbb{R}$  can be embedded in E'. Since each  $r \in \mathbb{R}$  can be regarded as a fuzzy number  $\overline{r}$  defined by

Let u, v, w  $\in E'$  and k  $\in \mathbb{R}$ . The operations addition, scalar multiplication and product defined on E' by  $u + v = w \Leftrightarrow [w]_{\lambda} = [u]_{\lambda} + [v]_{\lambda}$  for all  $\lambda \in [0, 1]$

In the sequel, we require the following Definitions and lemmas.

**Definition: 2.3** A sequence  $u = (u_k)$  of fuzzy numbers is a function u from the set N into the set E'. The fuzzy number  $u_k$  denotes the value of the function at  $k \in \mathbb{N}$  and is called the  $k^{th}$  term of the sequence. Let w(F) denote the set of all sequences of fuzzy numbers.

**Theorem 2.5** [7]. Let  $(u_k), (v_k) \in w(F)$  with  $u_k \to a, v_k \to b$  as  $k \to \infty$ . Then,

**Definition : 2.6** A sequence  $(u_k) \in w(F)$  is called bounded if and only if the set of all fuzzy numbers consisting of the terms of the sequence  $(u_k)$  is a bounded set.

That is to say that a sequences ( $u_k$ )  $\in$  w (F) is said to be bounded if and only if there exist two fuzzy numbers m and M such that  $m \leq u_k \leq M$  for all  $k \in N$ .

#### III. The space $\lambda_0(\mathbf{M}, \phi, \mathbf{p})$

Let  $\Lambda = (\lambda_k)$  be a sequence of non-zero fuzzy numbers and let  $u = (u_k)$  be any sequence of fuzzy numbers. Put  $\Lambda u = (\lambda_k u_k)$  and  $(\Lambda u)_k = \lambda_k u_k$ .

### IV. The space $\lambda_0(\mathbf{F}, \mathbf{p})$

Throughout, let  $p = (p_k)$  be a bounded sequence of strictly positive real numbers and  $M = max (1, sup p_k)$ . The space  $\lambda_0(F, p)$  is defined as follows.

Now  $\lambda_o(F, p)$  is endowed with two topologies one is the metric topology  $\tau$  given by metric d, where d

Then  $(\lambda_k u_k) \in c_o$ , (F,p) for every  $(u_k) \in c_o(F,p)$ . Hence  $c_o(F,P) \subset \lambda_o(F,P)$ . Always  $\lambda_o(F,P) \subset c_o(F,P)$ . Therefore  $\lambda_0(F,P) = c_0(F,P)$ . On the other hand suppose that  $\lambda_0(F,P) = c_0(F,P)$ .

If  $(\lambda_k) \notin \ell_{\infty}(F, P)$  then there exist a positive integer r such that for each r, there exist a k(r) such that

This contradiction shows that  $(\lambda_k) \in \ell_{\infty}(F, P)$ .

**Corollary 4.2**  $\lambda_{o}(F) = c_{o}(F)$  if and only if  $(\lambda_{k}) \in \ell_{\infty}(F)$ .

**Theorem 4.3** In order that  $\lambda_0(F,P) \subset \mu_0(F,P)$ , it is necessary and sufficient that

In either case  $\left\{ D \left( u_k \mu_k, \overline{0} \right)^{p_k} \right\}$  is arbitrarily small for sufficiently large k. Hence  $\lambda_0(F, P) \subset \mu_0(F, P)$ 

On the other hand if (4.3.1) is false, we can find an increasing sequence of positive integers {k(r)} such that  $\sum_{k=1}^{n} (1-\overline{\alpha}) P_{k(r)}$ 

$$\mathsf{D}\left(\gamma_{k},0\right)^{r(r)} \geq r$$

and  $D(\mu_{k(r)}, \overline{0})^{P_{k(r)}} \ge r$ . for  $r = 1, 2, 3, \dots$ 

 $If \ D(\lambda_{k(r)}, \ \overline{0} \ ) \geq 1$ 

Define

$$u_{k} = \begin{cases} r^{-\nu_{p}k(r)}, k = k(r), ?\\ 0 & Otherwise \end{cases}$$

Then D 
$$\left( u_{k(r)} \quad \mu_{k(r)}, \overline{0} \right)^{p_{k(r)}} \ge 1$$
  
If D  $\left( \lambda_{k(r)}, \overline{0} \right)^{p_{k(r)}} \le 1$   
Define  $u_{k} = \begin{cases} r^{-\frac{1}{p_{k(r)}}} & k = k(r) \end{cases}$ 

Then  $D\left(u_{k(r)}, \mu_{k(r)}\overline{0}\right)^{p_{k(r)}} \ge 1.$ 

Thus in either case,  $u \in \lambda_0(F, P)$  but  $u \notin \mu_0(F, P)$ . This contradicts the hypothesis that  $\lambda_0(F, P) \subset \mu_0(F, P)$ This completes the proof.

**Theorem 4.4**  $(\lambda_0(F, P), \tau_\lambda)$  is a complete metric space if and only if  
lim inf  $\left\{ [D(\lambda_k, \overline{0})^{p_k}]^{\frac{1}{M}} \right\} < 0$   
**Proof.** The proof is similar to 3.1

**Theorem 4.5**  $\tau$  is finer than  $\tau_{\lambda}$  if and only if

Let  $\epsilon > 0$  be any real number Let  $\{u^{(n)}\}$  be any sequence converging to zero in  $\lambda_o(F,P)$  with respect to  $\tau$ .

Then there exist some  $n_o$  such that  $D(u_k^{(n)}, \overline{0}) < \mathcal{E}/L$  for all  $n \ge n_o$ 

Consequently,

$$\sup_{k} \left\{ \left[ D\left(u_{k}^{(n)}, \overline{0}\right)^{p_{k}} \right]^{\frac{1}{M}} \right\} < \frac{\varepsilon}{L} \quad \text{for all } n \ge n_{o}$$
  
ie) 
$$\sup_{k} \left\{ \sup_{\alpha \in [0,1]} \max \left\{ \left(u_{k}^{(n)-}(\alpha)^{\frac{p_{k}}{M}}, |u_{k}^{(n)+}(\alpha)|^{\frac{p_{k}}{M}} \right\} < \frac{\varepsilon}{L} \quad (4.5.3)$$

using (4.5.2) and (4.5.3)

$$d_{\lambda}(u_{k}^{(n)}, \overline{o}) = \sup_{k} \left[ Du_{k}^{(n)}, \overline{o}^{p_{k}} \right]^{1/M}$$
$$= \sup_{R} \left[ D(\lambda_{k}, \overline{o})^{p_{k}} \right]^{1/M} \left[ D(u_{k}^{(n)}, o)^{p_{k}} \right]^{1/M}$$
$$< L \mathcal{E}/L = \mathcal{E} \text{ for all } n \ge n_{0} \qquad .$$

Therefore  $\{u_k^{(n)}\}\$  converges to zero with respect to  $\tau$ . In other words the identity map on  $(\lambda_0(F,P), \tau)$  onto  $(\lambda_0(F,P), \tau_\lambda)$  is continuous. Hence  $\tau > \tau_\lambda$ 

**Theorem 4.3.6.** Let  $(\lambda_0(F,P))$  be a complete metric space and let  $q=(q_k)$  be a bounded sequence of strictly positive real numbers. Then the following are equivalent  $i = \lambda_0(F,P) \subset \lambda_0(F,q)$ 

ii. 
$$\lim_{k \to \infty} \left( \frac{q_k}{p_k} \right) > 0$$

assume that (ii) is not true.

Then we can determine an increasing sequence of positive integers  $k(1) < k(2) < \dots$  Such that  $q_{k(i) < (1)}$ 

$$\left(\frac{1}{i}\right)p_{k(i)}$$

Define

$$\mathbf{u}_{k(i)} = \begin{cases} \left[\frac{1}{i(D(\lambda_{k(i)},\overline{0}))^{p_{k(i)}}}\right] & \text{for } k = k(i) \\ \overline{0} & \text{for } k \neq k(i) \end{cases}$$

Then D ( $\lambda_{k(i)} u_{k(i)}, \overline{0}$ )  $p_{k(i)} = \left(\frac{1}{i}\right) \Rightarrow 0 \text{ as } i \Rightarrow \infty$ 

Also 
$$D(u_{k(i)}, \overline{0})^{p_{k(i)}} \rightarrow 0$$
 as  $i \rightarrow \infty$ 

But

D(
$$(\lambda_{k(i)} \ u_{k(i)}, \overline{0}))^{q_{k(i)}} > \exp[-(\log i)/i] > \exp\left(\frac{-1}{2}\right)$$

This shows that u does not belong to  $\lambda_o(F,q)$  which contradicts (i) and (ii) must hold.

 $(ii) \Rightarrow (i)$ 

Suppose (ii) holds

Then there exists r>0 such that  $q_k\!>\!rp_k$  for all sufficiency large k.

 $\begin{array}{l} \text{Therefore } D(\lambda_k u_k, \overline{0} \ )^{qk} \ \leq \ [D(\lambda_k u_k, \overline{0} \ )^{pk} \ ]^r \\ \text{Thus } \lambda_o(F, P) \subset \lambda_o \ (F, q). \end{array}$
