Abstract

Maluku Province is a spice-producing region. The spices produced are generally sold without any processing. However, there are Small Business Enterprises that take advantage of these spices to be processed into black oil. This black oil is produced by the Black Oil SME and has been in demand by many consumers. However, these products have not been standardized, especially the permits from the POM office, apart from that, in this SME business, they do not have good business governance management. Therefore, in this research activity the research team seeks to help the problems of these SMEs. The purpose of this activity is expected to be able to help partners (SMEs) to provide assistance and arrange product testing from Drug and food control center (Balai POM). In addition, the research team will help manage SME business management with hope that this research activity could help to encourage sales turnover for these products.

I. Background

Black oil SME in Seith is a SME that has been exists for a long time with good income. Every month they produce 3-4 times of production, with sales turnover for each production of approximately 6 million, meaning that 24 million in 2022, while the previous year, namely 2022, had the same amount of turnover. Based on the problems fore-mentioned, the researcher plans to conduct a research to overcome the problem of black oil production, especially in business management in the field of marketing and obtaining BPOM license to get buyers interest. Thus it could increase business turnover.

Based on the problem identification above, the researcher will try to solve the problem as follows:

- 1. How to manage good business management?
- 2. How to apply for a B-POM license?

This research aims to:

1. Provide good business management assistance

2. Provide assistance in obtaining B-POM permits

II. Research Methods

The implementation of this research uses the Participatory Rural Appraisal (PRA) method. PRA is a method that involves partners in counseling/training activities, mentoring and activity evaluation to see the effectiveness of the program. It is hoped that the program will run well (Dewi, 2017). This activity was carried out for 3 days and evaluated for 2 days. The stages of activity include:

1. Partners are given material in advance to create good business management governance, especially in the field of marketing by a research team.

2. Partners are given an understanding in advance on how to obtain a BPOM business license by an emic person from BPOM for approximately 3 hours, it covers:

a. Types of Products that are eligible for BPOM permits (1 hour)

b. What is BPOM and the requirements for the procedure of BPOM (1 hour)

c. BPOM approval procedure (1 hour)

3. Direct practice partners assisted by the team to prepare BPOM licensing requirements.

4. The service team will evaluate the activities to see how far the effectiveness of the research program is, so that the planned program will run smoothly.

III. Result and disscussion

Result

In order to do Business Management Training and Assistance Activities and Licensing Processes from Balai-Pom for Black Oil, it was preceded by activities to carry out coordination activities with partners and villages. This activity aims to establish mutual agreement related to the implementation of research activities and time duration for conducting the activities. This activity then occurred for 2 days; on the first day coordinating with partners and discussing to convey what preparations have to be make for inspection from Balai POM. In addition, the team provides an understanding and insight to partners regarding the minimum requirements that must be prepared for research activities. On the second day the team conducted activities in partner location. The evidence of these activities is as follows:

Furthermore, researchers employed activities to assist the licensing process from Balai-POM for black oil. In order to conduct the licensing process from Balai POM, the first step taken was asking for the willingness of Balai POM to provide partners with explanation and understanding of the importance of product standardization and what requirements partners must fulfill in order to obtain a product license.
